School Information:

SPRING BREAK TRIP INFORMATION

Description of the Trip

Purpose or educational goal:

- To provide an opportunity for students of Progressive Academy to participate in a global education experience where they will:
 - Have opportunities to practice their Mandarin Language Skills
 - Experience life in several Chinese schools
 - Visit a number of significant cultural and historical sites in and around Beijing, Sanya, and possibly Hong Kong
 - Have the opportunity to develop their research and performing skills prior to the trip

Proposed itinerary (date, time, & destination) with brief description of all activities:

- Departing from Edmonton on the morning of March 19, 2025.
- Arriving in Beijing late afternoon of March 20, 2025. Transfer to hotel, dinner at local restaurant.
- March 21-23. Tour of Beijing's historical & cultural sites, including Tiananmen Square, the Forbidden City, Summer Palace, Great Wall & Hutongs. Visits to one or more Beijing parks. Shopping in Qianmen Street area. Experience a Tea Ceremony and Pedicab ride.
- March 24. Activities at PA's sister school, HESA-BJIE public elementary school.
 Students will be partnered with students of a similar age. Evening meal at home of host students.
- March 25. Activities at HESA-BJIE public elementary school. Alternate activities for parents and adults on March 27 (798 Art District and Houhai OR shopping). Evening Shopping or visiting a local park.
- March 26 Travel Day. Fly to Sanya, a popular resort city in China's southernmost province. Hainan. (4 hour flight)
- March 27 Visit the International School of Sanya. Students will lead a presentation to Chinese students and possibly enjoy a talent show hosted by TIS/SLS students.
- March 28 Visit one of Sanya's famous beaches. Possibly go sailing on Sanya Bay.
- March 29 Hainan siteseeing, including Nanshan Guanyin Temple, Yalong Bay Beach, Yanoda Rainforest Area,
- March 30 Mid-day flight to Hong Kong, evening activities in Hong Kong
- March 31 Tour famous sites of Hong Kong, including Victoria Peak, Stanley Market
- April 1 Visit Hong Kong Disneyland, evening flight to Canada from HK International
- April 1 Arrive in Vancouver, clear customs and transfer to Edmonton for an evening arrival home.

NOTE: Participants will be provided with hotel contact cards and supervisor contact cards to keep with them at all times. Where possible, all travelers with cell phones will be on a WeChat group allowing constant communication while in China.

Methods of transportation to be used

- Commercial Air Carrier, likely Air Canada for international flights and Chinese domestic airlines internally.
- Bullet Trains may be used for transport within China.
- Commercial Coaches to be organized by Beijing Travel Agent.
- Possibility of Cabs and Beijing Subway System.
- Host families (in Beijing and if applicable, in Sanya) may transport students to their homes by automobile or on public transportation.

Cost to the participants

- Estimated at \$5500 Cdn or less / Participant (subject to some fluctuation if Canadian Dollar vs Chinese Yuan exchange rate fluctuates, and if increasing world oil prices impact that cost of aviation fuel)
- includes transportation, minimum of two meals per day on non-travel days, accommodations and most entry fees. Based on double/twin occupancy
- Single Supplement will apply for those wanting single rooms.
- It is customary to contribute to gratuities for tour guides and bus drivers

Description of Trip Supervision

General Supervisory Arrangements: There will be a minimum of 1 school staff member for each 8-10 students. Because many parents will be participating, the adult to student ratio will be very favorable.

- Supervisors will hold daily information meetings.
- Supervisors will carry cellphones with a minimum of texting capability.
- Nightly room checks for unaccompanied students.

- Chaperones will have first aid training.
- Progressive Academy will notify the Canadian Embassy in Beijing.
- Prior to departure PA will check with Canadian Consular Affairs for safety precautions in Beijing and Hainan areas.

Supervisory Arrangements during Activities:

- Participants required to attend all meetings.
- Participants will be required to carry contact information cards at all times.
- Students in grade 6 or younger are required to be accompanied by a parent or adult guardian.
- Students under 16 must remain in adult-led groups at all times while on site-seeing or shopping excursions unless explicitly cleared by parents and chaperones.
- Unaccompanied students are strongly encouraged to have a cellphone with international texting capability.

Supervisory Arrangements at the Hotels

- We will ensure that all students are in the hotel by having supervisors periodically checking on the students in their rooms. Students will be given the teachers' room #s.
- If hotels have swimming pools, students who are not accompanied to the pool by a parent must be under the direct supervision of at least one teacher. At least one teacher will be out of the pool checking to make sure students are okay in their rooms.
- All unaccompanied students will be ready for bed and in their rooms no later than 10:00 p.m. Curfew times may be extended by chaperones depending on the context.
- The school will provide Male and Female Chaperones.



Consent and Authorization

Important: Participants, parents/guardians. The following sections contain important information. Please read them carefully and ensure that you understand them completely.

Changes to Itinerary and Associated Costs

I understand that the trip will follow the description of the field trip set out above as closely as possible. I also understand that contingencies can arise that necessitate sudden changes to activities and destinations.

I agree that the supervisors of the field trip have full authority to make decisions of this nature without obtaining my further consent. If such changes involve extra cost, I agree to repay Progressive Academy for those costs associated with my child.

Cancellation of Field Trip

I understand that the Principal has full authority to cancel or modify any field trip without notice for any reason the Principal deems appropriate. I also understand that such cancellation may mean that some or all of the money I have paid for the field trip might not be refundable.

I agree that the Principal has such authority and that Progressive Academy will not reimburse me for any money I may have lost as a result of such cancellation.

Discipline

I understand that my child must obey the rules established by the school and the field trip supervisors.

I agree that if my child severely breaches the rules, he or she might be sent home. I also agree that if my child is sent home under such circumstances, I will be responsible for all associated costs incurred, including the cost of special travel arrangements for my child and a chaperone.

Illness and Injury

I understand that illness and injuries sometimes occur on field trips.

I agree to purchase international travel & medical insurance and furthermore agree that that if illness or injury necessitates the expenditure of money for special travel arrangements or any other reason deemed necessary by the field trip supervisors, I will be responsible for all of those costs. I authorize any of the adult supervisors on the field trip to consent, in my absence, to any medical attention my child may require.

CONDUCT POLICY REGARDING EXTRA-CURRICULAR ACTIVITIES & TRIPS

Extra-curricular and school field trip activities are an extension of Progressive Academy and students need to be aware that at all times they are expected to abide by the Progressive Academy Student Code of Conduct, as posted on the school's website.

Students are reminded that when we are out in public, the conduct of one student may be interpreted as an extension of the conduct of all Progressive Academy students. It is our expectation that all participants on this trip will be ambassadors of not only Progressive Academy, but of Edmonton, Alberta, and Canada.

The school chaperones will normally counsel students who are in breach of the Student Code of Conduct. Should the offending behavior re-occur or should it endanger the health and safety of other participants and or hosts, more serious disciplinary action can occur, including out of school suspensions, or in the worst case, being sent home at personal/parental expense.

Please note that should a student's in-school behavior leading up to this trip be consistently problematic, the Progressive Academy staff may refuse to allow the student's participation on the trip.

CONSENT & WAIVER FORM

I have read and understood all of the above. I have obtained any additional information I feel I need in order to satisfy myself that I want myself/my child to participate in the field trip.

ASSUMPTION OF RISK

I am aware that by participating in the Progressive Academy Spring Break 2020 Trip to China I/my child will be exposed to many inherent risks and dangers ("Risks") that may result in, among other things, mild or severe illness, physical injury, partial or total disability, death, and/or property loss or damage. These Risks include but are not limited to risks and dangers arising from:

- 1. **TERRAIN AND PHYSICAL ENVIRONMENT** whether visible / apparent or not, and any manner of injury or loss of any nature whatsoever arising therefrom including, without limitation, injury or loss arising from falls on steep, slippery or uneven terrain, from falling rocks, trees or other objects, from obstructions, from other participants, from landslides, etc.;
- 2. TRAVEL including, without limitation, travel to and from any locales scheduled to be visited or not by any means whatsoever including, without limitation public or private bus, motor vehicle, boat, aircraft, etc., and injury or accident from loading/unloading equipment or supplies from vehicles and any manner of injury or loss of any nature whatsoever arising therefrom;
- 3. **WEATHER** and any manner of injury or loss of any nature whatsoever arising therefrom including, without limitation, loss or injury resulting from exposure to weather conditions, including but not limited to cold, heat, sunlight, snow, ice, wind, hail, rain, sleet, fog, mist, etc.;
- 4. **LOCATIONS** and any manner of injury or loss of any nature whatsoever arising therefrom including, without limitation, loss or injury arising from becoming lost or injured, the inability to receive prompt or any medical services for any reasons, war, terrorism, political unrest, riots, disregarding safety instructions, violence, etc.;
- 5. **NON-HUMAN LIFE** of any nature whatsoever, including, without limitation, any animal, insect, fish, bird, fungus, vegetation, bacteria or viruses and any injury or loss of any nature whatsoever arising therefrom:
- 6. EQUIPMENT, MACHINERY OR OTHER DEVICES including, without limitation, any equipment deployed in respect of the Progressive Academy Spring Break 2025 Trip to China or otherwise and any manner of injury or loss of any nature whatsoever arising therefrom including, without limitation, loss or injury arising from the use, misuse, malfunction or breakdown of any equipment, machinery or similar device that may be deployed or used;
- 7. OTHER HAZARDS including, without limitation, hypothermia, allergens, noxious gases, electrocution, shock, drowning, chemicals (including, without limitation, herbicides, pesticides, acid and caustic bases), radioactive nuclides, radiation, x-rays, flying rock chips, vandalism, or theft of property, and any manner of injury or loss whatsoever arising therefrom; and
- 8. **FREE TIME** including, without limitation, anything arising from my or my child's participation in activities or functions that are not directly related to the Progressive Academy Spring Break 2020 Trip to China, including, without limitation, tours, walks, hiking, shopping, sports activities, dancing, alcohol or drug ingestion, intoxication and/or alcohol/drug poisoning from alcohol or drugs I or my child consume whether voluntarily or through coercion, and others and any injury or loss of any nature whatsoever arising therefrom.

I agree with the foregoing and freely accept and fully assume all Risks and acknowledge the possibility of, and agree to be solely responsible for personal injury, death, disability, property damage or loss resulting from the Risks except where such arises as a result of the negligence or wilful misconduct of the Progressive Academy. - 2. travel insurance adequate for the Progressive Academy Spring Break 2020 Trip to China and the circumstances I find myself in with respect thereto and having regard to the Risks and that no travel insurance will be provided by Progressive Academy. I acknowledge that any travel insurance I obtain should provide coverage against theft, personal accident, personal liability, repatriation (whether medical, political or in the event of death) and cancellation of tickets. Progressive Academy accepts no responsibility for any costs associated with these types of problems nor will it pay for any expenses that may be incurred by me relating to these areas.

I agree with the foregoing and freely accept and fully assume all responsibility for the purchase of myself &/or my child with medical/health and travel insurance coverage and to be solely responsible for any loss or injury whatsoever arising as a result of my failure to obtain such insurance or as a result of the type of insurance I purchase, _____ (Initials)

- i) my participation in any activities outside of the Progressive Academy Spring Break 2025 Trip including, without limitation any activities conducted in my/my child's free time;
- ii) my/my child's participation in the Progressive Academy Spring Break 2025 Trip where any loss or damage of any nature whatsoever is caused by my/my child's negligence or wilful misconduct or any other cause except for the negligence or wilful misconduct of Progressive Academy;
- iii) any cancellations, injury, loss, accident or delay occasioned by the proprietor, employee, or service of any hotel, hostel or other type of accommodation, resort, facilities and equipment, or mode of transportation used in conjunction with the above noted Progressive Academy Spring Break 2025 Trip; or
- iv) any failure to disclose on the Emergency Information for Progressive Academy Spring Break 2025 Trip form any known medical condition that could endanger my/my child's health and/or life while participating in the above noted activities.
